# **RULES AND REGULATIONS**

## **Rules & Regulations**

**\* Miss Jr. Teen Delegates must be between the ages of 13 and 15 yrs old. Single, never married and never given birth,**

**\*Miss Teen Delegates must be between 16 and 18 yrs old. Single, never married and never given birth – if you are a high school senior, you may compete as a MISS**

**\*Miss Delegates must be between 19 and 25 yrs old. Single, never married and never given birth,**

**\*Ms. Delegates must be between the ages of 26 and 43, single, divorced or widowed and may have given birth.**

**\*Mrs. Delegates must be at least 21 years of age, married and currently living with husband by the State pageant date and may have given birth.**

**\*Ms. Classic Delegates must be 44yrs and up married, single, divorce or widowed and may have given birth.**

**All Delegates must have lived in Texas at least one year and will live in Texas at least one year after competition date.**

**\*Delegates agree to look solely to the TEXAS UNITED AMERICA pageant State Director, with respect to all matters relating to this application, the preparation, rehearsals, and selection process and all matters to the pageant.**

**\* Delegate permits her likeness, photograph and name to be used by the TEXAS UNITED AMERICA pageant in any and all publications/advertisements associated with the State pageant.**

**\*Should delegate decide to withdraw from the pageant at any time, under no circumstances will she be entitled a refund, either full or in part, that delegate, a sponsor or advertiser will have paid.**

**\* Delegate must be of good moral character and must not have committed any act inconsistent with the highest standards of public morals and conventions, which would reflect unfavorably on the pageant, its representatives, sponsors, director and/or licensees.**

**\* Delegates must furnish her own transportation to and from pageant.**

**\* Entry fee for competition in the TEXAS UNITED AMERICA pageant is \$300.00 and there is a required sponsor fee of \$350.**

Top 5 may advance to NATIONALS with a discount towards fee and given a temporary State title. Any other participants, or others, who wish to come "At-Large" to the NATIONALS, may do so, but must pay fee and will receive a temporary State title for the competition.

**\*Arrangements must be made for payment, but fees must be Paid in Full one month prior to State competition. Additional sponsor pages may be purchased at a cost of \$95 for ONE HALF page and \$175. for full page.**

These rules and regulations are subject to change without prior notice. We reserve the right to make said changes at our discretion. Failure to adhere to these rules and regulations could lead to possible forfeit of title at that time you will relinquish and return all gifts and awards to the national office.

Each contestant must submit this signed statement that you have read and understand and agree to these rules before you will be able to enter pageant.
